

#### WELCOME

Thank you for joining us for *Australian Transport–Policy Challenges for Future Growth*, BTRE's 7th Transport Colloquium.

Australia's non-bulk freight transport task continues to grow more quickly than the economy overall—container port traffic substantiallymore—while the passenger and personal transport task increases faster than the rate of national population growth. So coping with transport growth and the issues it gives rise to—ensuring the right amount of infrastructure capacity, securing regulatory outcomes that are compatible with efficiency, innovation and service, introducing best practice system management and overcoming congestion—is an important policy challenge for our economic future.

Transport, almost by definition, comes with some adverse impacts for the community and the environment. But tackling climate change has renewed urgency in Australia and throughout the world as both an environmental and potentially an economic issue. How to achieve significantly reduced fossil fuel consumption in the various parts of the transport sector as in other sectors, while safeguarding future economic growth, is a key policy challenge. Also very important is the challenge to continue to reduce the human and economic cost of road and other transport accidents.

I am delighted to welcome to the colloquium all our invited speakers. I particularly acknowledge the Hon Mark Vaile MP, Deputy Prime Minister and Minister for Transport and Regional Services and Professor Werner Rothengatter, Head of the Institute of Transport and Communication at the University of Karlsruhe, Germany. Professor Rothengatter's keynote address on European investment and regulation policy in the transport sector and the challenges which Europe faces should provide a benchmark for our own policy challenges for future growth. It will also be a thought-provoking point of departure for the discussion sessions to follow.

Welcome and thank you again for taking part in the 2007 BTRE Transport Colloquium. I hope you will find these two days of discussion both rewarding and enjoyable.
